

Terms and Conditions for Artwork Purchase

1. Introduction

These terms and conditions govern the sale and purchase of artwork (including but not limited to postcards, prints, and other artistic products) offered by Slobodan Marceta (Artist) through the website ([Slobodan At Oxford](#)). By making a purchase, you agree to these terms and conditions. Please read carefully before placing an order.

2. Trademarks & Copyrights

The Artist retains all rights to the artwork, including copyrights and reproduction rights, unless explicitly stated otherwise in writing. The artwork sold through this Website is for personal use only and may not be reproduced or resold without the Artist's express permission.

Pepper Street Foundation (PSF) and other marks indicated on our website are trademarks or registered trademarks of PSF in the UK, European Union, and/or other jurisdictions. PSF graphics, logos, page headers, button icons, and other similar items, are the trademarks or trade dress of PSF; these may not be used in connection with any product service or website that is not PSF's, in a way that is likely to confuse or that disparages or discredits PSF. All other trademarks not owned by PSF that appear on this website are the property of their respective owners and Artists.

3. Orders and Availability

To purchase from us you must be over 18. The Artist reserves the right to refuse access to our websites, terminate accounts, terminate transactions, or remove or change the content at our sole discretion. If we cancel a transaction, it will be without charge to the customer.

All Orders placed on the website will automatically receive a confirmation e-mail of the transaction. It is the customer's responsibility to check any email filters that may interfere with our communication with you.

Orders - By placing an order on the Website, you agree to purchase the artwork at the specified price and adhere to the terms outlined herein. All orders are subject to availability and confirmation.

Availability - all goods are sold subject to availability. If we are unable to supply the goods, we will inform you by telephone or email of this as soon as possible, normally within 48 hours. A full refund will be given when you have already paid for the goods and the transaction will be cancelled. Should you wish to choose another item of the same value this is acceptable.

4. Pricing and Payment

Prices for artwork are listed on the Website and are inclusive of applicable taxes (if any) and shipping costs. Payment must be made in full at the time of purchase through the provided payment methods on the Website.

We aim to be accurate but are subject to sudden changes in availability, and discounts, and human & technical error will occur from time to time. We aim to inform you as soon as possible if this happens. Prices can go up as well as down. Your options are: a full refund where you have already paid for the goods and the transaction will be canceled or we adjust your bill and process a lower or higher fee.

5. Shipping and postage fees

The Artist will make every effort to ensure prompt delivery of purchased artwork. Shipping times and costs may vary depending on the destination and shipping method chosen during checkout. The Buyer is responsible for providing accurate shipping information. The risk of loss or damage to the artwork passes to the Buyer upon shipment.

Most items are FREE Delivery for UK customers. International customers will normally be charged a delivery fee.

When a product has a delivery charge, its Price will not include the postage and packing charge - this will be an additional cost at the checkout stage.

6. Returns and Refunds

The Artist strives for customer satisfaction. If you are not entirely satisfied with your purchase, please contact us within [7] days of receiving the artwork to discuss a possible return or refund. Returned artwork must be in its original condition. Refunds, if applicable, will be processed after receipt and inspection of the returned item.

Note: Postcards are not available to be returned or refunded.

7. Privacy

Any personal information provided during the purchase process will be handled by our Privacy Policy [[link to privacy policy](#)]. Your information will only be used for purposes related to your purchase and will not be shared with third parties without your consent.

We share any of your data with Third Parties such as shopping or payment gateways.

The Data Protection Act 2018 applies, as does the General Data Protection Regulation (GDPR) (EU) 2016/679. We are registered members of the Information Commissioner's Office (ICO).

You may write to the data controller at our place of business above, to query what data is held about you. Please contact us for the appropriate address.

In no event shall the Artist or PSF be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or related to the purchase or use of the artwork.

9. Governing Law

These terms and conditions shall be governed by and construed by the laws of England. Any dispute arising out of or in connection with these terms and conditions shall be subject to the exclusive jurisdiction of the courts of English courts.

10. Modifications

The Artist reserves the right to revise these terms and conditions without prior notice. Any changes will be effective immediately upon posting on the Website. By continuing to use the Website after such changes, you agree to be bound by the updated terms and conditions.
